Are you interested in obtain the class B driving licence in English? But, like many others, you can't manage the Spanish theory lessons and the Spanish teaching material, though you do speak and understand the language of this country reasonably well? Even the "second generation" which has been growing up with both languages, now prefers the English version of theory driving lessons, because it has proved to be more successful.

The controls of the local police have recently been considerably intensified and even multilingual special units have been employed. Therefore times of leniency and lack of knowledge about what is a valid driving licence are finally over. € 1.500,- Multa (fine) will have to be paid by a "offender without a driving licence" additional to the obligation to immediately register with a driving school and present the registration including the confirmation that the fine has been paid, to the Trafico.

Should the "offender" be caught again without a driving licence a second time, the fine will double and the chance to obtain the driving licence will be forfeit for a considerable time (a criminal charge will be made and there will be a 2 year period before re-application).

"KLAGUSCH EU DRIVING LICENCE SERVICE" in co-operation with the driving school GUATIFAY therefore has created a training course. The new programme is directed at the English speaking people living in the Canary Islands.

If you live in Lanzarote or Gran Canaria you can make the theory and practical learning and the exams on your island.. If you live on another island or the mainland of Spain you have to come to Lanzarote to do the theory part. For the practical part you can choose to stay in Lanzarote or return back and do it with our partner driving schools in the other parts of Spain.

We Offer EU – Driving Licence Class B

- **Learning material in English / Part I**
Learning Book and extensive exercise samples with exam forms – Spanish features – answer forms and more.
With this material you learn at home first.
For the provided learning material we will charge a deposit of €75. This will be returned or charged against the costs, after the material has been returned undamaged.
- **Theory crash course in English** (5 days / 4 hours.) in
LANZAROTE / Arrecife or **GRAN CANARIA / Playa del Ingles**.
Students from other islands or the mainland of Spain come to Lanzarote., and we will be glad to help finding a lodging not too expensive.
- **Learning material in English / Part II** (Crash-course)
You learn in small groups with an English speaking teacher, which takes place in **Lanzarote a. Gran Canaria**
- **In LANZAROTE (Autoescuela GUATIFAY in Arrecife) we have single learning computer places to learn more effectually.**
- **In LANZAROTE** the practical driving lessons and exams take place in Arrecife .
- **In GRAN CANARIA** the practical driving lessons and both exams take place in Las Palmas.
- **We will provide a special vocabulary list (Spanish/English) for the practical driving lessons.**

Costs

You can repeat until you passed every exam with a renew paying of the costs..

You can only start with the practical driving lessons if you passed the theory driving exam.

Documents for the registration

- **Certificate of Residence** **(Original)**
Empadronamiento – issued by the Ayuntamiento
Not older than 3 months before the first exam.
- **Passport or Residencia** **(Copy)**
Note! To the exam please also bring the original of the documents, that you copied for the registration!
- **N.I.E. Number** **(Copy)**
If you have a Residencia this will not be necessary.
- **6 Photographs** (2 for the Certificado Medico – 4 for the driving school) **(Original)**
Important! Have to be fairly new and Spanish Standard Size and a white background.
- **Certificate of Health** **(Original)**
Certificado Medico (Valid for 3 months before the first registration in the Trafico)
Will have to be issued by an authorised “Centro Medico“(Especially for student driver applicants)
and will have to be paid separately. €30
(2 photographs necessary)

During the “Learning period” at home with your exercise form and textbook, you should obtain these documents as soon as possible.

Please note:

The time span between time of registration and the actual date of the examination can be up to 3 weeks. It is therefore imperative in your own interests to register and obtain the documents as soon as possible.

Simultaneously with the delivery of the necessary documents (for the registration) to our partner driving school the charge for the Trafico will have to be paid, €77.

It is therefore up to you how quickly you finish YOUR driving licence

It is your own decision how fast you obtain your necessary documents, how intensively you study at home with the learning material provided by us, last but not least how attentively you participate in our crash course (which details the Spanish examination categories). The only one who can pass the exam is YOU. We can only provide the basic principles of the subject in English!

Procedure

- By recording your details and the payment (€400+€75,) by bank transfer to the business account of “KLAGUSCH EU DRIVING LICENCE SERVICE” at the bank **La Caixa** ; account number: **2100-1510-36-0200209921** or the payment in cash at the office/Lanzarote, you will be pre-registered and receive the learning material for you home study.
- During your learning period at home you will have to obtain the necessary documents for your registration at the Trafico as soon as possible.
- After you have gone through these important steps you will attend the next possible crash course (you'll be informed of the date).
- The crash course and another book will concentrate on the Spanish traffic laws, as you will already have obtained a basic knowledge about the general subject through your home study – always assuming that you actually did learn. Without learning at home a crash course won't be possible and your written exam will be reset at your own expense.
- To do the exam at the Trafico you bring your documents to our Partner driving school and pay the charge (Tasas y Gestión) 77 € You will have to attend for the written examination at the respective “Trafico” at the appointed date (it will be given to you by us and is obligatory).
- After passing the written exam, the practical driving lessons will generally start in the next or following week (can be later if requested). The practical training will be carried out in several steps with the agenda set by the respective driving school. After completing them, and all are paid, you will attend the practical exam.
- If you passed the practical exam the interim driving licence will come to the driving school after nearly a week. The final driving licence card will be sent to your address, known by your documents, by post after approx. 4 weeks.

Just a word....

With hindsight many people have considered the driving examination is one of the most stressful ones in their lives. The possession of the driving licence is becoming taken for granted by most 18-year-olds; the one who doesn't have that sought-after paper will stand out. Even worse it is for the ones who have been driving in the archipelago for months or even years without a driving licence and have now decided, due to the reinforced controls, to obtain one. To do that it is imperative to know the Spanish traffic laws, which can only be conveyed through an intensive home study and a crash course.

Imagine the loss of prestige if one doesn't pass the examination – especially since some believe that they will pass easily due to their “extensive experience” and others think in their youthful exuberance that an intensive learning course won't be necessary. Even the second generation – that usually has a good command of the Spanish language – likes to resort to our English programmes after they've failed the Spanish examination several times. It would have saved them a considerable amount of money had they done this in the first place.

With tedious labour we've created an extensive learning material in English and German. Examination forms in English and German have been obtainable at the official services (Trafico) for quite some time, but up to now no teaching material, exercise forms, not to mention crash courses, were available, which meant that the student drivers appeared at the examinations entirely unprepared and had to accept the results.

The crash course, which according to the articles of traineeship has to be attended by our student drivers, will engage the Spanish traffic laws, which are predetermined in the road traffic regulations and will certainly be included in the examination questions. All categories, which could appear in the examination, will be addressed. We cannot give specific questions for the forthcoming examination, as it is not possible, since all examination questions are considered to be classified documents by the Spanish authorities.

With hindsight many people have considered the driving examination is one of the most stressful examinations in their life, but thanks to our crash course and our learning material in English this stress can be alleviated.

Terms of Business

1. The registration for the driving course class B has to include the theory and practical driving instruction. By paying the price and registering for the driving course the student driver has the obligation to participate in the theoretical and practical driving lessons. All documents necessary for the registration to the examinations should be provided as fast as possible and in ones own interest an intensive home study should be started immediately.
2. Together with the preferment of your necessary documents at the partner driving school you have to pay the charge for the Trafico (tasa y gestión) €77. Without a confirmation of this a registration at the Trafico is not possible.
3. If the student driver doesn't attend the crash course or decides to discontinue the driving course, the co-operating driving school has the right to deny a participation in the exam. In this case the student driver won't be able to claim any refunds from KLAGUSCH EU DRIVING LICENCE SERVICE of payments already made.
4. The same applies to force majors or events outside the control of the KLAGUSCH EU DRIVING LICENCE SERVICE (such as debarment of the student driver from the examination by TRAFICO due to invalid documents, misconduct at the examination, false statements concerning personal details, failure to fulfil the age guidelines, or the breach of other official guidelines and requirements).
5. If the student driver doesn't attend the examination at the appointed date, KLAGUSCH EU DRIVING LICENCE SERVICE and the partner driving school has the right to charge a separate reservation, and handling fee amounting to €157. This amount will have to be paid before the new admission to the examination. In case of nonfeasance KLAGUSCH EU DRIVING LICENCE SERVICE has the right to instantly terminate the indenture. In this case fees already paid will not be refunded because the exclusion was brought about by the student driver's own fault.
6. The written and practical examinations must not be attended under the influence of alcohol. Misconduct during the lessons distracts the other learners and therefore we authorise the teacher to expel the offender from the course and terminate the indenture without prior notice. As in clause four, fees already paid will not be refunded as the exclusion was brought about by the student driver's own fault.
7. With its English teaching programme KLAGUSCH EU DRIVING LICENCE SERVICE offers a support for self-study and cannot give any guarantees for passing the official examinations. It is in the student drivers power alone how he/she pursues the private studies, understands the subject, and how intensive he/she puts into practice the "Spanish traffic laws", which will be discussed in the crash course. It also depends on how he/she follows the guidelines in the theory and practical lessons.
8. After the student driver passes the written examination the practical driving lessons will be allocated by the respective driving school on the particular island in accordance with the company's procedures. These driving lessons are to be completed in the area of the practical examination. Special dates can be requested but the driving school is not obligated to grant them.
9. The scope of services by KLAGUSCH EU DRIVING LICENCE SERVICE includes the provision of learning material (against payment of a deposit) and the textbook or rather the 'Crash-Course Exercise Folder' and a five day crash course in Lanzarote and Gran Canaria with an English speaking teacher. (At this time only in Lanzarote) we offer single computer places with the learning program.
10. After passing of the written examination the learning material will have to be returned complete and in good condition in exchange for the deposit which was paid for it. All provided exercise forms; textbooks etc. are the property of KLAGUSCH EU DRIVING LICENCE SERVICE and are subject to copyright laws. The careful handling of this document is expected and the return is obligatory. Damage, loss or violation of the copyright will result in a high claim for damages and the loss of the deposit!
11. The registration (**Matricula**) and the deposit is to be paid to **KLAGUSCH EU DRIVING LICENCE SERVICE**. All the following has to be paid directly to the **partner driving school**.
